

Background and objectives

- The RCGP is currently reviewing its position on whether assisted dying should be legal across the UK and in the Crown Dependencies.
- The RCGP commissioned Savanta to run a member survey, that will help to inform future discussions and a decision by the RCGP Council about the position the RCGP should take on whether assisted dying should be legal or not in the UK and the Crown Dependencies.
- The survey was designed to provide a non-binding, representative view of the RCGP's membership on the issue of assisted dying.
- The survey seeks to aid the RCGP Council's decisionmaking by seeking the views of the RCGP membership on how to best proceed in the event of there being no clear majority for any given approach.



What we did



5-minute online survey



Email invitations (and reminders) to 53,539 records from the RCGP membership database



8,779 responses achieved



Fieldwork: 24th January to 10th February 2025

Who we surveyed

This survey was open to all members of the RCGP listed their database as training, eligible to work or has previously worked as a GP in the UK, one of the Crown Dependencies, or the Republic of Ireland. There are several different categories of RCGP membership, and the following were in scope for this survey:

Member	This category of membership is for GPs who are on the GMC and GP register and have been awarded full membership
GP registrar	This is category is for those who are currently in GP training
Fellow	This is the highest grade of membership where members have applied for and received recognition of their contribution to general practice
Associate	This for other members who are on the GMC and GP register, who are not eligible for or have not applied for full membership

Response Rate and Representation

The survey was distributed to a total of 53,539 potential respondents, with 8,779 completing the survey. This is a response rate of **16%**.

The high level of participation for the RCGP survey shows a strong response rate, providing survey results that are likely to be highly representative of the RCGP membership when weighted. A response rate of over 10% is generally considered robust, especially for large-scale surveys.


Throughout the fieldwork, measures were taken to ensure survey accessibility and visibility. These measures included Savanta mailouts and social media posts from the RCGP and contributed to the high response-rate seen overall.

Respondent Profile

Savanta surveyed a total of 8,779 RCGP members from 24th January to 10th February 2025.

The 5-minute-long survey was conducted online, with respondents drawn from a sample file provided by RCGP.

The final survey data was weighted to be representative of the overall RCGP membership data, on the basis of gender, location, age, and membership type.

Contextualising the research

Prior to displaying the two core survey questions, respondents were shown six information screens that contextualised the format and purpose of the research.

- Respondents were made aware of the RCGP reviewing its position on assisted dying and were provided links to the most recent previous RCGP consultation on this topic and a briefing paper setting out the context.
- Respondents were informed of Savanta being commissioned by the RCGP to run the survey.
- Respondents were informed that their answers would be anonymous and processed in compliance with the Market Research Society (MRS) Professional Code of Conduct.
- The RCGP provided key definitions of words/phrases used in the core questions.

The RCGP provided the following definition of assisted dying:

The RCGP defines assisted dying as the act of intentionally assisting a person to end their own life, at that person's voluntary request. This includes healthcare professionals prescribing lethal drugs for a patient to self-administer – which is sometimes referred to as 'physician-assisted suicide' or 'physician-assisted dying', and healthcare professionals administering lethal drugs – which is often referred to as 'voluntary euthanasia'.

All respondents who completed the survey would have seen this definition.
