Full petition text

We, the undersigned constituents, call on _____ MP to vote against the Terminally Ill Adults (End of Life) Bill at Third Reading.

We are deeply concerned that this Bill would put vulnerable people at risk who may feel pressured into seeking assisted suicide, for example, because of the costs of their care. The Bill includes no eligibility requirement for someone to be in any pain or suffering, they simply need to have a terminal diagnosis with six or fewer months left to live. Not only are such prognoses notoriously unreliable, but people would be eligible for assisted suicide simply because they felt depressed after a terminal diagnosis or could not access adequate palliative care. We should offer such people support, not suicide.

The Bill has insufficient protections for vulnerable groups, would put hospices and care homes at risk through the lack of conscience protections, would conflict with the historic principles of the NHS, and would likely expand over time, as has happened in other countries.

We join the Association of Palliative Medicine and the Royal College of Psychiatrists in opposing this Bill and ask you to vote against it at Third Reading. Please support improving palliative care provision instead.

Why collecting names on this petition matters

On Friday, 20 June 2025, MPs will place their final vote (Third Reading) on Kim Leadbeater's dangerous assisted suicide Bill

Only 28 MPs needed to change their minds after Second Reading to defeat it – several already have. That makes this fight winnable – but only if people like you take action in your constituency.

Your local MP could cast the deciding vote on the Bill, and your signature has real power. A petition signed by a large number of people in your local constituency calling on your MP to vote against the Leadbeater assisted suicide Bill will carry real weight.

If enough people in your local constituency speak up and sign the petition, it will be very persuasive in getting your local MP to turn up and vote NO when it really matters – at the crucial final vote on the Bill on 20 June.

Every single vote will count. The numbers are tight, and the stakes couldn't be higher. A flood of local signatures to your MP could tip the balance and help stop this dangerous Bill in its tracks.
